Loveland - On Monday evening, 9 April 2007, approximately 1,000 Patriots came together to Honor and Remember our Fallen Heroes and Staff Sergeant Matt Maupin.

The patriotism emanating from within The Oasis, at times, was electrifying. Politics and partisanship, pro-war vs. anti-war, stopped at the front door. Inside The Oasis, only Honors were rendered to Our Fallen Heroes, their families, to SSG Maupin, and

his parents Keith and Carolyn. These 1,000 Patriots arrived in all matter of dress, from blue jeans and tennis shoes, to tuxedos and formal dresses. U.S. Army and Marine Corps personnel were likewise present in their dress uniforms. What mattered the most however, was not what they wore, but their support for Our Fallen Heroes, and their families.

MINUTES OF MARCH 2007 MEETING

The 124th regularly scheduled meeting of the Chosin Reservoir Detachment was held on 21 March 2007 at the VFW Post in Morrow, Ohio, beginning at 1900 hours.

- 1. A roll call of officers revealed all were present, with the exception of Frank DePaul and Dick Ratliff. 2. Application for New Membership(s): None. 3. Minutes from previous meeting were read and were approved by a unanimous vote of the members. 4. Paymaster gave his treasury report: we have \$2,400.10 in the account.
- **5.** Correspondence: Received Newsletters from Montezuma-Cincinnati Det #270, Belleau Wood Det #508, and Pvt Henry Kalinowski Det #782. Forwarded Det #508 Newsletter to 24 Chosin Reservoir Marines.
- 6. Report of Members or family sick or distressed: Shirley Fry (Bill Sr's wife) came through surgery OK, and is doing well. Marine George Copeland is holding his own. 7. Report of Officers. [a] Sr. Vice: neg rpt [b] Jr. Vice: 4h Comm Co is going to Camp Atterbury next month for Gas Chamber, Drivers Training and Rifle Training.
- 8. **Standing Committees:** [a] **Uniforms** New Catalogs available. [b] **Warren County Veterans Service Commission** (**WCVSC**) **Report:** Vern Flannery reported the WCVSC disbursed \$ 19,222.13 this period. [c] **Shooting** Target World is a "no go". Det will wait for better weather and hold our next shoot at Vern Flannery's Target Range. [d] **The Chosin News** Editor On Vacation.
- 9. New Business: [a] Election of Officers & Trustees for year 2007 2008 include: Commandant: Frank Hetzer; Sr. Vice Cmdt: Terry Consider; Jr. Vice Cmdt: David Florea; Paymaster: Fred Renton; Adjutant: Frank DePaul; Judge Advocate: Vern Flannery; Sgt-at-Arms: Bill Fry, Jr; Chaplain: Chris Schott, Jr; Trustees - 3 Yr: Walter Golladay; 2 Yr: Bill Fry, Sr; 1 Yr: Frank DePaul. The Detachment election were held, and all Officers & Trustees were elected. [b] Telephoned our Department Judge Advocate John Maurer in Columbus, OH regarding our Tax Exempt Status. John said "we are covered by a letter issued Jul 31, 1948 by the IRS Deputy Commissioner with "Original Exclusion Letter". On October 2, 1969 the league received a copy of the original letter dated July 31, 1948, issue the league a form # 501C4. Any donations made to our detachment for \$250.00 dollars or more, should be given a letter acknowledging that donation. The letter should be made out on our letterhead. [c] Marine Vern Flannery says "we have a chance to sell our old trailer to the Warren County Veterans Commission." Vern and Frank Hetzer discussed letting them have it for whatever they wanted to donate. Detachment confirmed with a motion to accept any gift received as final settlement. [d] Regarding personalized Marine Corps shirts...Frank Hetzer asked Dick Ratliff and Paul Trimble for their reports. They were getting the following: supplier, style of shirt and cost. [e] Officers & Trustees will be sworn in at April 18, 2007 meeting. Uniform of day will be: MCL Red Blazers, black trousers, white shirts, black tie. No MCL Star Burst on collars. Marines w/o Red Blazers should wear: Black Trousers, white shirts, black tie, and (optional) MCL Star Burst on collars. Note: Wives or Girl Friends are invited to this meeting. We'll be serving food and drinks after the meeting.
- **10. Old Business:** [a] Get your tickets for Cash Bash May 5th. A motion was presented and passed to purchase 50 flags at \$3.00 each for MCL. **11. Good of the League:** [a] Life Member cards were presented to Derek Fry, Jr and Jimmy Kay.
- 12. The Next Meeting was set for 1900 hours, 18 April 2007. With no further business before the Detachment, the meeting concluded with a rousing rendition of the *Marine Corps Hymn* www.instantknowledgenews.com/marine.htm
